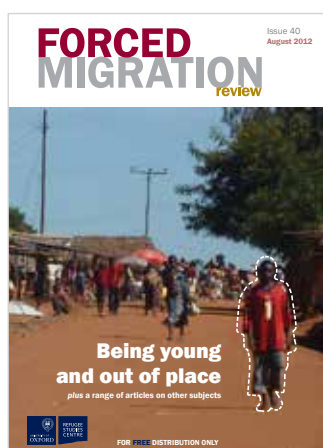

Being young and out of place

FMR 40, August 2012

Being displaced involves not just a change of physical location but a dislocation of many aspects of normal life, and young people may be particularly susceptible to being physically and socially 'out of place' during this period of their lives. FMR 40 includes **26 articles** that examine the stresses of 'being young and out of place', explore young people's needs and coping strategies, and ask why relatively little attention is paid to their rights and needs.
